1	The total number of section of the school shall be restricted to 15. Further increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by elaws and subject to the availability of room size of greater than 500 sq ft.	
2	The ramp at the entrance is not seen in the IC video. The ramp to access first floor is very steep which cannot be used by a wheel chair user. Hence the school is directed to ensure ramp at the entrance, ramp / lift to access upper floor with proper infrastructure as per guidelines of RPwD act and submit the compliance within 3 months on SARAS portal.
